1. Federal Leadership Announce Presidential Directive to Strengthen Biodefenses

President Bush has made strengthening the nation's defenses against biological weapons a critical national priority. Federal departments and agencies have reviewed their efforts to find new and better ways to secure America from bioattacks. The results of the review is "Biodefense for the 21st Century," a Presidential directive released on April 28, 2004. The Department of Health and Human Services (HHS), in cooperation with the Department of Homeland Security, has created a fact sheet on biodefense preparedness that pulls highlights from the Presidential directive. 2. NASEMSD EMS Rural Needs Survey Results Available

The State EMS Rural Needs Survey was conducted as part of the development of the national "Rural/Frontier EMS Agenda for the Future." It replicates part of "Challenges of Rural Emergency Medical Services – An Opinion Survey of State EMS Directors," a report published in 2000. The portions replicated include the identification of needs and issues important to the provision of rural EMS, and the perceived need for capital budget items for the provision of rural EMS. Personnel "recruitment/retention" remains the single most significant issue or need in the provision of rural EMS according to both the 2000 and 2004 surveys. "Financing" remained a prominently identified need through both surveys, while "24/7 coverage," "communications," and "response time" emerged as far greater concerns in the 2004 survey than in 2000. "Communications equipment" was the most often cited capital equipment/facility need in both surveys by slight margins. "Training equipment," "medical equipment" and "ambulances" also finished strong in the 2004 survey. For more information on the survey, contact NASEMSD's Kevin McGinnis at mcginnis@nasemsd.org.

4. NEMSIS Task Force, State Data Manager, and EMS Software Developers Meeting Scheduled for June

On June 8-10, 2004, in Washington, D.C., there will be a group of meetings for the NEMSIS Task Force, state data managers, and EMS software developers. The meeting will provide an update on NEMSIS, the NHTSA version 2 Dataset and its implementation. Participants will discuss the status of the Memorandum of Agreement that has been endorsed by 44 states and territories. The meeting will provide a draft proposal and definition of what "compliance" means with respect to the NHTSA dataset and XML standard and discuss how compliance with the NHTSA dataset and XML standard may determine which software may or may not be used by local EMS systems in states endorsing the Memorandum of Agreement. Finally, the meeting will promote dialogue on how to improve and promote the NEMSIS initiative to make sure it stays in touch and in line with the EMS industry. 7. FICEMS Bill Introduced

Advocates for EMS is encouraging interested parties to contact their Senators and ask them to cosponsor S. 2351, the Emergency Medical Services (EMS) Support Act of 2004, which would establish a Federal Interagency Committee on Emergency Medical Services (FICEMS). This committee would coordinate various Federal agencies that are involved in EMS, including Health and Human Services; Homeland Security Department; and National Highway Transportation Safety Administration. Senator Collins (ME) and Senator Feingold (WI) introduced S. 2351 on April 27, 2004. Senators should be contacted by May 7, 2004, if possible. 8. House Passes Continuity of Government Bill

On April 22, 2004, the U.S. House of Representatives passed the Continuity in Representation Act of 2004 (H.R. 2844). This bill amends Federal law concerning the election of Senators and Representatives to require States to hold special elections to fill vacancies in the House of

Representatives within 45 days after a vacancy is announced in the extraordinary circumstance that vacancies in representation from the States exceed 100. The Senate is considering the bill.

9. DHS First to Define Interoperability Requirements for First Responder Community

The U.S. Department of Homeland Security's (DHS) Science and Technology Directorate on April 26, 2004, announced the release of the first comprehensive Statement of Requirements (SoR) document outlining future technology requirements for public safety wireless communications and interoperability. The SoR, developed under the SAFECOM Program, marks the first time the 50,000 public safety agencies have a document that defines future requirements for communicating and sharing information – as authorized, when and where needed, and in a manner that allows for the most effective use of that information. 10. CMS Issues Educational Article of Interest to Ambulance Providers

The Centers for Medicare and Medicaid Services (CMS) has developed a new Health Insurance Portability and Accountability Act (HIPAA) educational article of interest to ambulance services that use third-party billing companies. 12. CDC Futures Initiative Updates Provided

In the last two months, Centers for Disease Control (CDC) has considered several organizational prototypes, representing varying degrees of change for the organization. These prototypes were shared with partners by mail and at a broadcast on April 12. Based on input from within the CDC and from outside partners, CDC has determined that it can achieve many of its priorities by retaining the best elements of the current structure, while enhancing its ability to address strategic imperatives. 13. NHTSA Requests Reports on All Unintentional Deployments of Automotive Safety Equipment

Recently, there has been increased media attention about the potential dangers of extrication-related deployments of automotive safety equipment (i.e. airbags, seat belt pretensioners, etc.) to emergency personnel during rescue and EMS operations. While there have been reports of injuries to rescuers, the prevalence of these types of incidents is not known. NHTSA's Crash Investigation Program and Emergency Medical Services Division will continue to monitor and analyze the problem. In order to determine the extent and nature of any hazard, and design appropriate countermeasures, it is crucial that NHTSA receive information on as many of these incidents as possible. 14. ANSI HSSP Biometric Report Released

Biometric technologies are becoming the foundation of an array of highly secure identification and verification solutions. They consist of automated methods of identifying a person or verifying the identity of a person based upon recognition of a physiological or behavioral characteristic. Physiological characteristics include hand, finger, facial, iris and speech. Behavioral characteristics are traits that are learned or acquired, such as dynamic signature verification and keystroke dynamics. ANSI has a Homeland Security Standards Panel that is working on this issue. A recent workshop identified five issues that need to be explored. First, there is a need for a single certification body for biometrics products that are expected to be utilized by the Department of Homeland Security and the Transportation Security Administration. Second, there is a need for speaker recognition interoperability standards. Third, there needs to be a performance-testing program for biometric standards. Fourth, conformance-testing methodologies should be developed for the biometric interoperability standards under development. Finally, the users need, in the shortest timeframe possible, the performance evaluation standards that are being developed under INCITS/M1 and JTC 1/SC 37.
